## **Township Liability Insurance.**

The Township's liability insurance coverage renews 7/1. Loar-Porter sought proposals from Par Plan/Tokio Marine (current carrier) and Hartleb Agency/EMC. Peterson stated the lack of coverage and claims support from Tokio Marine the last few years has not been good at all.

Smith answered the questions from the May meeting concerning the budget. The budget does include \$37,500 for expenses related to the Capital Project plan that is required to be developed by 8/1. The Township engineer will make certain the Authority engineer is not completing work for Lincoln Township that has already been completed.

The City is also requesting a turbin being placed into the water tower that stirs the water, this creates better quality in the water in the case that the water is needed.

**Board Member Comments.** Stauffer reported the Roosevelt Path project is moving along. Bidding will begin in July.
