**APPROVAL OF MINUTES**

**DEPARTMENT OF BUILDING SAFETY**

The Department of Building Safety, year to date has issued 27 permits for single family dwellings, last year there was 17. For the month of August there were 4 permits issued for single family dwellings. For the month of August 2017 there were 4 permits issued for single family dwellings.

At this time last year, house construction values alone totaled \$4,544,950. This year they are at \$7,884,500.

In 2018, total construction (building, electrical, mechanical, plumbing) permits for Commercial, Industrial, Agricultural and Residential districts estimated total values are at \$12,979,932. In 2017, total construction values were at \$11,413,161.

In the month of August there were 326 inspections made on (building, electrical, mechanical, plumbing, and rentals).

**NEW BUSINESS**

Master Plan review and update.

**Freehling** talked with Township Planner **Wells** regarding the Master Plan and felt no major changes were needed at this point. There were no census data available to update. After some discussion, it was suggested that it may be noted in the newspaper for suggestions from the public for legitimate master plan updates.

**Olszewski** went through his recommendations of the sign committee. (Attachment A) After a brief discussion, **Freehling** asked for a motion. **Florian**, seconded by **Barbott**

ZBA could deal with pole signs. **Youngstedt** noted the Exit 23 cleanup will be September  
23<sup>rd</sup>.
